**GENERAL AGREEMENT:** The mare owner agrees to breed the designated mare above to the servicing stallion during the 2025 breeding season. The Mare Owner agrees to pay a stallion fee of **\$1,750.00** of which \$250.00 deemed as the booking fee is payable with this contract. The balance being due prior to the first shipment. A current copy of the mare's registration papers (both sides) are to be sent back with this contract. Booking fees are non-refundable. This contract cannot be transferred or sold to another Mare Owner. The breeding season begins on February 1st and ends on June 1<sup>st</sup> of current year.

**LIVE FOAL GUARANTEE:** The stallion owner/agent guarantees a live foal. A live foal is defined as a foal that stands and nurses without assistance. If the mare fails to conceive, aborts the foal, dies or the foal dies within 24 hours of birth, the mare owner is entitled to one rebreed. The rebreed must be used in the 2026 breeding season. Should the stallion die or become unfit for service, the stallion owner/agent's liability shall be discharged fully. Should the stallion be sold the new owner shall be obligated to honor the terms of this contract.

**SHIPPED COOLED SEMEN:** Semen requests must be received no later than 9:00 p.m. (eastern standard time) the night before the regular collection days of Monday, Wednesday and Friday. **SEMEN IS SUBJECT TO AVAILABILITY.** Orders will be filled in the order in which they are received. The mare owner will assume the risk and expense associated with a lost or delayed shipment and shall hold Horseshoe Lake Farm harmless. The first collection and shipping fee is included in the Stud Fee of \$1,750.00, if a second shipment is necessary in 2025, the cost is \$500.00. Mare owner is responsible for returning the Shipping Container back to Horseshoe Lake Farm at the Mare owner's expense.

The mare owner's signature attests to the fact that the mare owner has read and understands all of the outlined herein and accepts this contract as a legal and binding instrument in the State of Ohio. This contract cannot be assigned or transferred. A Breeder's Certificate will be issued upon notification of the birth of the foal, providing all accounts are current.
